My friends, here we are in August. I'm afraid things are not back to "normal" yet... whatever that might be. I have sort of lost track of what normal was anymore! We knew, though, that the COVID-19 pandemic wasn't going to go away any time soon.

Hopefully, you know that both Garfield and Lac qui Parle started having services again. Lac qui Parle started having outdoor services on July 12 (10:15 a.m.- they plan to hold outdoor services at least through the end of August, weather permitting), and Garfield started having "in-sanctuary" services on July 19 (8:30 a.m.). Please come only if you are healthy and do not display any of the symptoms related to COVID-19.

If you are not able to come to church or have health-related issues that prevent doing so or are just not comfortable doing so, remember that we will continue to livestream the Garfield service on my Facebook page, which will post to the Garfield and Lac qui Parle FB pages, the LqP Sunday School FB page, and also to YouTube. Of course, we will have the video services available to view in Madison at 1 p.m. on Channel 8. For those of you coming to the services in person, thank you for wearing your mask and maintaining at least 6 feet distance from the next individual or family group.

I would like to tell you what the plan is for Sunday school at Lac qui Parle and also confirmation classes, but I need to wait until July 27 to find out about how public school classes will be conducted (it is July 22 today as I am writing this article). Once that announcement is made, then we can try to figure out how we will have those education classes in our churches.
